**A Bully in the White House**

Socialism is prompted by one idea more than any other. President Barack Obama gave vent to it recently when he was interviewed by Meredith Vieira of NBC News.

What do I mean? While the blood of righteous Abel was still warm and cried out to God from the earth, the first murderer asked, "Am I my brother's keeper?" Socialists in their temerity go further and ask, "Is my brother not my keeper?" That is just as, if not more, important than his birthplace. We have placed a radical Socialist in the White House a follower of Babeuf, a herald for the claptrap of the French revolution. The debate over healthcare proves my point.

**What Happened to Privacy?**

Americans believe not only in *laissez-faire* economics (There is such a thing as a market, and we should leave it alone so that it can operate freely without government interference, or private monopolies who would if they could fix prices); Americans take this one step further. They also believe that people should be allowed to operate freely. And apparently Obama does not accept that dictum. If you get in his way you had better be prepared to take it on the chin. Step aside Tony Soprano there is a new kid on the block; one who believes that his understanding of the

common good is what is good, and that anything other than that is what is bad, and if that is the case he has been sent to save us from the bad. {This is called a “messianic complex.”} So what is good and what is bad according to Obama?

## **The Bully Has a Pulpit**

Obama knows that he has the right to use what has commonly been called a bully-pulpit, but he uses it like no one else before him. He also failed to mention that many uninsured are wealthy enough to provide insurance for themselves.

It has become a caretaker government.
